President's Message ... from the desk of Moira Botham

Welcome to another change of season. Autumn is usually a busy time, full of changes: the lazy days of summer give way to the more harried days accompanying return to work or school...and with the change of pace comes the nagging knowledge that winter lurks just around the corner.

In thinking of what to write that might be worthy of a 'presidential note', I started to reflect on change. If you who don't know me, you might think that this would lead to a gentle, artsy daydream of the myriad of changes in our society. Ha, I'm far more inclined to think of change in terms of how it affects health in our workplaces – so I thought I'd write a bit on that.

We all recognize that change is necessary – but it is rarely easy. According to a recent study of 600 organizations in the UK, stress is the number one cause of long-term work absence and, unsurprisingly, workplace change is to blame for the majority of this stress.

How can occupational hygienists assist to mitigate the stress of workplace changes? Ever thought of stress as a health hazard? Well, it is. And once we consider stress as a hazard, we can see that we are well equipped to use the standard tools of our profession to address it. Yes, the REC (recognition, evaluation & control) concepts can be used to fight stress. Once workplace stress programs are framed using these tools, they appear less subjective and from a management view, easier to support.

While we all appreciate the hard science associated with our profession, I would encourage you to look for ways to use the REC tools to address non-conventional health hazards...perhaps try using REC to frame a management program for stress in your workplace. You may be surprised that you can more easily garner support from higher levels of management for this increasingly important health hazard.

Since Angela has kindly produced a newsletter that provides you with the hard news from our local section, it is left to me to colour outside the lines a bit and share some thoughts. Alberta H&S Conference Fun Run - Volunteers Wanted

AIHA Alberta members,

Volunteers are required for the 2nd annual 5K Fun Run/2K Walk associated with the Alberta Health and Safety Conference this October, in Calgary. Proceeds for this run are going to Threads of Life, an organization that supports the families of those who have been affected by workplace injury, illness or fatality.

The out and back run/walk route starts and finishes at the Eau Claire Market in the downtown area. Start time is 9:00 AM Monday morning, October 24th. Currently, 10 to 12 people are required to marshall along the urban trail route to provide directions to participants and to cheer people along the way. One person with First Aid certification is also required to cycle the route during the event.

Route marshalls would need to be in place on the route prior to the run start and would be finished as the last participant passes by them on the return to the start/ finish line. It is anticipated the time commitment would be approximately 1.5 hours, but all volunteers are welcome to join the post–run gathering where there will be refreshments and draw prizes! Overload - Spring PDC Review

The annual spring Professional Development Conference was held on March 10, 2011 in Calgary. Melanie Walls, MA, MSc, Human Factors Specialist presented a daylong training session titled 'Overload – What is it and what can we do about it?" Ms. Walls engaged participants on a variety of topics related to mental workload and the relationship of overload to workplace incidents.

Throughout the day, many practical exercises were used to demonstrate to participants how various factors affect mental workload. We were also introduced to a variety of methods on how to measure mental workload in the workplace. Well-known industrial accidents were reviewed with the specific purpose of reviewing the mental workload issues that contributed to the failures.

Ms. Walls concluded the day with reviewing strategies for managing mental workload including strategies for both overload and underload with reference to the hierarchy of controls. Finally, we reviewed the strategies that could work for each of us on an individual level.

Ms. Walls engaged her audience with practical examples and humorous and applicable anecdotes from her own experiences. Our next PDC will be scheduled for Fall/Winter 2011 and will take place in Edmonton. Stay tuned for more details.
